## **Whereas**

- 1) Pursuant to Article 59(3) of Regulation (EC) No 1907/2006 of the European Parliament and of the Council of 18 December 2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) the European Chemicals Agency (hereinafter referred to as 'ECHA' or 'The Agency') received from Member States six dossiers in accordance with Annex XV to REACH for substances which in their opinion meet the criteria of substances of very high concern (SVHCs) set out in Article 57 of REACH.
- 2) On 06 September 2016, the Agency invited all interested parties to submit comments on the Annex XV dossiers, as stated in Article 59(4) of REACH.
- 3) The public commenting period for all substances ended on 21 October 2016.
- 4) In accordance with Article 59(5) of REACH, the deadline for Member States or the Agency to comment on the identification of the substances as SVHCs was 07 November 2016.
- 5) The Agency received comments on the identification as SVHCs for the following substances:

- 6) Thus, pursuant to Article 59(7) of REACH the dossiers related to these substances were referred to the Member State Committee (MSC).
- 7) The MSC unanimously agreed via written procedure, which closed on 02 December 2016 that the following substances meet the criteria set out in Article 57 of REACH for identification as SVHC:

- 10) Therefore, pursuant to Article 59(8) of REACH the Agency shall now include these substances in the Candidate List for eventual inclusion in Annex XIV to REACH.
- 11) The Member State Committee at its 51st meeting did not unanimously agree that the following substances meet the criteria set out in Article 57(f) of REACH:

- 12) Therefore these substances shall not be included in the Candidate List. The Member State Committee's majority opinion in support of the identification of the substances as substances of very high concern and the minority views shall in accordance with Article 59(9) of REACH be referred to the European Commission for final decision-making.
- 13) In accordance with Article 59(10) of REACH, the updated Candidate List shall be published on ECHA's website.
